CAN in Automation is pleased being able to offer you exhibition space in form of CiA product panels, at **Interlift**, **Agritechnica**, **and SPS 2025**. If you would like to exhibit your product as part of the CiA product panel wall, please provide the completed order form (see following page) to CiA.

Note: Every shown product is linked to the related CiA Product Guide entry, via a QR-code. Basis for one CiA product panel is a plate with the size of 30 cm x 30 cm (length x width).

CiA product panel requirements:

• Panel size: 30 cm x 30 cm (length x width)

• Maximum product size: 30 cm x 30 cm x 30 cm (length x width x height)

Maximum product weight: 10 kg

- · Safety requirements:
 - Providers are responsible for the safety of their products. Unsafe products will not be exhibited. The decision regarding the safety of products rests solely with CiA.
 - In case power supply is provided, it is for illumination purposes only. No touchable voltages, no movements, are allowed.
 - It is not required for the product to be fully operational. A housing or a dummy device may be exhibited, if appropriate.

Cancellation Policy:

In case of your cancellation of participation, in case of not providing your product till the submission deadline given in this document, or in case of providing an unsafe product that thus cannot be exhibited, a charge in the full amount of the costs mentioned is invoiced.

Financial Obligations:

CiA GmbH is entitled to withdraw from the contract, if you do not meet the financial obligations arising from this contract, and a 14-day grace period set by CiA GmbH is not met either. In case you breach the contract, CiA is also entitled, in addition to withdrawing from the contract to charge you the price for the ordered CiA product panel as lump-sum compensation. The CiA's right to demand further compensation remains unaffected.

Force Majeure:

If, as a result of force majeure or for other reasons for which CiA is not responsible, CiA is forced to vacate the booked stand space temporarily or for a longer period of time, or if the trade show is postponed, shortened or canceled completely, and CiA is not able to exhibt your CiA product panel, you are not entitled to withdraw from the contract, terminate the contract, reduce the price or assert any claims, in particular claims for damages against CiA GmbH.
